## Child Safeguarding Statement

1. Name of College: Colaiste UISCE

### 2. Cineál na seirbhíse agus prionsabail chun daoine a chaoimhnú ó dhíobháil

(A brief summary of our services, what we do and our commitment to protecting children)

Colaiste UISCE is an Irish Language College and Adventure Centre where a lively, professional and safe Irish language is taught through adventures on land and at sea. We strive to foster a positive Irish language learning environment. We respect each other's rights and safety and make every effort to behave in a positive and cooperative manner.

Colaiste UISCE recognises the importance of the Children First Acts 2015 & 2017 and The Criminal Justice (Withholding of Information on Offences against Children and Vulnerable Persons) Act, 2012 and the National Vetting Bureau (Children and Vulnerable Persons) Acts, 2012 – 2016. We endeavour to adhere to these guidelines to provide a safe learning environment for the children in our care.

Colaiste UISCE's policy is in line with 'Children First: National Guidance for the Protection and Welfare of Children' Published by the Department of Children and Youth Affairs (2011) & (2017); A copy of which is available in the office.

Colaiste UISCE's policy follows the guidelines set out in the document 'Our Duty to Care' published by the Department of Health and Children (2003).

Colaiste UISCE recognises the importance of a positive, safe learning environment, for all in our care, during the adventure sports, other activities and the accommodation provided by UISCE. Safeguarding children is always at the forefront in all of the college's policies. Training is provided for all staff members at the start of each Summer.

The policy is for all UISCE staff members including - prefects, bean an tís, permanent staff, bus drivers, instructors, teaching staff, housekeeping staff and kitchen staff. All staff members have an obligation to be aware of the policy and it is our responsibility to ensure the policy is adhered to in order to safeguard the children in our care. Therefore, the main points of the policy are in each handbook and training syllabus.

Staff are instructed to be alert to the possibility that children they are in contact with are experiencing abuse and to watch out for unusual signs/symptoms. (E.g. Significant change in behaviour, bruising, black eye).

It is the responsibility of every staff member to protect children by providing a safe environment, by being respectful and by actively listening to them and their opinions.

A child who has suffered abuse will be under great emotional stress and a staff member may be the only adult whom they trust. The staff member must put the child at ease and keep their trust as he/she explains that action must be taken and that the support of another adult/agency will be sought. It is important to explain that every effort will be made to support the child in every way possible, however do not make any promises that you can not keep (e.g. you will keep it a secret.) As illustrated in the Department of Health guidelines, the three basic principles are; confidentiality, discretion and sensitivity at all times. The DLO is responsible for ensuring the policy is reviewed every year before the Summer courses begin and to ensure that it is current.

### 3. Risk Assessment

We have assessed any potential for harm to a child when using our services, including in the area of online safety in the case of internet access. Below is a list of the primary identified risk areas and a list of procedures for managing those risks.

Children are made aware of the system on their first night at the college and again in the accommodation. "Tell Us" notices are displayed in the centre as well as in the accommodation houses.                                       |

Training in the following policies and procedures are part of those courses; bullying, childcare, fire, illness & accidents & safety. Notices are posted around the centre and in the accommodation houses regarding our "Tell Us" policy. |
| 3<br>Risk of harm due to bullying  | Coláiste UISCE has a comprehensive anti-bullying policy and it is updated every year. "Tell us" notices are posted in key areas. A minimum of two bullying questionnaires are conducted with students during a two-week course. A member of the teaching staff meets daily with the cinnirí agus a daily report is received from the bean an tís.   |
| 4<br>Risk of harm due to accommodation and provision for children                            | Coláiste UISCE runs a yearly training course for supervisors. The Bean an Tís have a training night. They receive a Coláiste UISCE handbook which includes; Safeguarding Children, "Tell Us" policy, and Coláiste UISCE rules. "Tell us" notices are posted. A member of the teaching staff meets daily with cinnirí and receives a daily report from the bean an tís.  |
| 5<br>Risk of harm due to travel and movement of children                                     | Cinnirí travel on the bus with the students, one for each household. When walking on the road the cinnirí wear a hi-viz vest and keep the group together.   |
| 6<br>Risk of harm to children with vulnerabilities/needs specific                            | Coláiste UISCE request parents to inform the college in advance if their son/daughter has a specific need. When necessary, a specific mentoring plan is set out for the child. The staff are informed and asked to be aware of the student and his/her needs, ensuring he/she is settled and happy. Daily meetings are held with the cinnirí and daily reports from the bean an tís.  |

They are returned for 20 minutes after dinner. They must be used in the dining/living area under the supervision of a member of staff/bean an t. Phones are not permitted in any other area of the centre/house. All other technological devices are prohibited. |

In addition to this, induction training is provided to all staff in relation to child protection.  |

#### 4. Procedures

In accordance with the Children First Act 2015, Children First: National Guidance and Tusla Guide in relation to Safeguarding Children, Coláiste UISCE agrees with the statement set out in this document with respect to Safeguarding Children. In addition to the procedures listed in our risk assessment, the following procedures support our commitment to protecting children when using our services:-

- A procedure for managing allegations of abuse or misconduct against workers/volunteers in relation to a child attending the college;
- A procedure for the recruitment and selection of staff members, volunteers and host family's suitability with regard to working with children, the Coláiste will ensure that candidates are Garda vetted as is legally required under the National Vetting Bureau (Children and Vulnerable Persons) Act 2012 to 2017.
- Procedure for the provision of information and, where necessary, the training of staff members and host families to recognise the signs of harm (as defined in The Children First Act 2015);
- Procedure for reporting child protection or welfare concerns to Tusla;
- Procedure for maintaining a list of persons who are mandated persons;
- Procedure for appointing the appropriate person, and a Designated Liaison Person (DLP) has been appointed by UISCE's steering committee;
- Procedure for recording training received by staff and host families (bean an t);
- A copy of the college's Child Protection Statement has been provided to all staff, new members and local host families.

With regard to reporting concerns to Tusla, all staff members and host families must adhere to the procedures set out in The Children First Act 2015, including those related to mandatory reporting. In Coláiste UISCE a Designated Liaison Officer (DLO) has been appointed by the College Management as the appropriate person (as defined in the Children First Act 2015) in respect of the first point of contact in relation to a statement regarding Safeguarding Children. Mandated persons include every registered teacher working in the College, the Education Manager and the College Manager as set out in the Children First Act 2015. A comprehensive list is included in this policy.

#### 5. Implementation

We recognise that implementation is an ongoing process. Coláiste UISCE is committed to implementing this Child Protection Statement and the procedures that support our commitment to keeping children safe from harm while under our care. This Child Protection Statement will be reviewed on 11/4/2027, or as soon as practicable after any material change has arisen in relation to anything to which the statement refers.

In undertaking this risk assessment, Coláiste UISCE has made every effort to identify, to the extent possible, the risks of harm that are relevant to the house and to ensure that adequate procedures are in place to manage each risk identified. While it is not possible to predict and eliminate all risks of harm, we have put procedures listed in this risk assessment in place to manage and mitigate the risks to the extent possible.

Coláiste UISCE Management completed this risk assessment on 11/4/2026.

It will be reviewed as part of the annual review of Coláiste UISCE's Child Protection Statement.

Dearadh an polasaí caomhnaithe leanaí UISCE ag teacht le 'Tús Aite do Leanaí: Treoir Náisiúnta um Chosaint agus Leas Leanaí' atá foilsithe ag An Roinn Leanaí agus Gnóthaí. Tá cóip ar fáil san oifig.

Cloíonn polasaí Cholaíste UISCE leis na treoirínte atá leagtha amach sa doiciméad 'Our duty to Care' a d'fhoilsigh an Roinn Síainte agus Leanaí (2003).

Creideann Udarás Cholaíste Uisce go gcaitfear cúrsaí in UISCE, spórt, imeachtaí éagsúla agus lóistín an cholaíste a chur ar síúl in atmaisféar atá dearfach, sábháilte agus moltach do gach éinne. Tá cosaint an pháiste chun tosáigh i gcónaí i bPolasaithe an Cholaíste. Cuirtear cúrsa oiliúna ar síúl don fhoireann go léir roimh thús an tsamhraidh.

Tá cosaint an pháiste chun tosáigh i bPolasaithe an cholaíste agus réachtáiltear cúrsaí insealbhuíthe chun an olltúint chuí a chur ar fáil don fhoireann ar fad chomh maith le hachóimre & na príomhphointí a bheith curtha sna lámhleabhar éagsúla. Déantar insealbhuí leis na bailí fhoirne ar fad; muinteoírí, mná tí, teagascóirí, cinnirí, lucht na cistine, lucht tí, an fhoireann riaracháin, tionsánaithe bus an cholaíste ina measc. Tugtar treoir do na bailí fhoirne a bheith san airdeall ar an bhféidearthacht go bhfuil na leanaí faoina gcúram ag fulaingt ó mhí-úsáid agus faire amach do chomharthaí neamhghnácha (eg athrú suntasach ar iompar, brúadh, súil dhubh etc).

Tá freagracht ar gach ball foirne leanaí a chosaint trí thimpeallacht shábháilte a sholáthar, trí bheith measúil agus trí éisteacht go gníomhach leo agus lena gcuid tuairimí.

Beidh an duine óg a d'fhulaing mí-úsáid faoi strus agus seans gurb é ball foirne UISCE an t-aon duine fásta a bhfuil muintín acu as, Ní mór an duine óg a chur ar a s(h)uaimhneas agus a mhíniú di/dó gur gá tacaíocht ó

## 6. Dearbhú
